Pat Tingle with the AEC (Aurora Event Committee) was present. He mentions February 21st was bingo night and they had a great turnout. March 20th will be the next bingo night. May 1st is the adult prom with formal wear. They talked to Valero about using land for a tractor pull for Gala Days. John mentions them using the already existing gravel roadway by the ball diamond.

Board of Adjustments meeting will be held on the 19th of March.

Mark Potthast with the Fire Department gave the report for the department. They had 4 calls this past month. Mark mentions building an auger for silo rescues and the department will also be attending some training classes as well.

John Muller gives the maintenance report. Dates for the Cleanup day in Aurora were discussed and the City will be talking to Cook's Wastepaper for available days. John mentions the lagoons and sewer

projects which includes a bigger force main and will require more space. He states that Josh Spilde offered to sell some land to the City for \$20,000 allowing the City to add a force main and future improvements, as well as possible area for water drainage for that area of town. Dixon asks about any costs of all paperwork, preparations, ground work, and materials. Those numbers depend on what is done and when. Pat Tingle mentions his concerns of the land being sold to the City for too much money compared to what it is worth. Geise makes a motion to purchase the land. Pace seconds the motion. Carried.
