Discussion on getting online bill pay option for residents. There was a lot of discussion on this item. More information will be provided and revisited. Asmus motions to table, Geise seconds motion. Carried.

Pat Tingle was present to discuss gala days. He states that the AEC is continuing to plan and still has the bands lined up. They will keep revisiting this during the covid pandemic. Mayor asks that the AEC considers cancelling the inflatable. AEC agrees. AEC asks the city for the possibility of a cash donation instead of the inflatable. Council asks questions about the street dance and the safety concerns on that.

Mike Ahartz gives the fire department report. Reporting 3 Fire calls and 5 EMS last month. They applied for a 50/50 grant for future equipment.

John Muller gives the maintenance report. He states that two leaks have been fixed on Santema and Broadway which is roughly 65,000 gallons of water a day. There are also some electrical breaks that need to be fixed.
