She states that Mr. Howards issues started in 2017. He developed spinal issues from bending and lifting because of the flooding. Cadence Construction built the home, Kevin states. Ms. Reed mentions that the City had sent out a letter regarding pumping on the streets and should not have. The city apologized for doing so. The Council asks that we get looking deeper into not allowing any basements in the area on new construction and also look into a different way to drain the water away from the homes.

Susan Plaine was present to discuss the traffic concerns on Redmond Rd. Susan and many other residents are very concerned about the traffic speed on that road. There are many people who walk, run, ride bikes and walk dogs on that road and they are hoping the City will put up a stop sign to help with traffic control and safety. They are asking that sign be put up by Lindsay Dr. and Redmond Rd. corner. There will be a resolution allowing those stop signs to be put up on the August meeting.

Pat Tingle with AEC was present. He mentions that there will be music in the park in Aurora on Sunday from 1:00-5:00pm. There will be pizza and soda for sale as well. They are inviting all city council members to be in the parade for Gala Days. There will be a cook-out held by K Country Radio held in the park on Friday August 6th, 2021.

Mike Ahartz gives Fire Dept. report. Reporting 6 fire calls last month. The Aurora Fire Dept. trucks may be headed back out West to help combat fires soon. Brush 2 will be getting the water tank upgraded to hold more water. Mike mentions the need for a new bumper on a fire truck which will cost \$2,135.00. M/S Schuttloffel, Price to approve purchase. Carried.

Collin Kneip - Maintenance report. Construction on Broadway is now complete. The basketball court fence will be tore down and the court will be resurfaced soon. There will also be new hoops added. There

will be a preconstruction meeting for the sewer project coming up on July 15th with the city and Banners Engineers. Collins asks about putting blacktop down on the West side of the Catholic Church and the Memorial Park.
