Kukrall suggests writing up an ordinance prohibiting parking on the East side of Dogwood. Mayor Weekes says that trailers should not be allowed to be left on the streets either. An ordinance will be ready for a first reading in December.

Craig Ulrich was present. He asks the council about a survey that was done on a property in Spilde Addition. The City does not have the report yet. He asked if Audra Dr. could also have a study done. Craig asked about Ag First and the dust control efforts. Price mentions that Aurora is an Ag community and that there has to be some dust expected and says that we have been trying to work with Ag First to help control it.

Mike Ahartz gives fire dept. report. Reporting 1 fire call and 7 EMS calls last month. Engine 4 had a large water leak and is getting repaired. The department is still looking at getting a new fire truck.

Collin Kneip gives the maintenance report. He says that they have been preparing for winter and all snow equipment is ready to go and has been serviced. He reports that the sewer project has been coming along very well and most of the areas on roads have been repaired as well.
