

The Aurora City Council met in regular session on Monday, January 05, 2025 at 6:00pm in the Aurora Maintenance Shop.

Mayor Jones called the meeting to order at 6:00pm and started with the Pledge of Allegiance.

M/S to accept the bid from Todd Smidt for the 2000 haulmark trailer for \$900.00. Carried.

Maintenance Report - Shannon Stuefen - New lights are up in the shop and Christmas decorations on Broadway are down.

M/S Price, Meyer to enter into executive session for discussion on personnel. All in favor, Carried.

M/S Kneip, Schuttloffel to come out of executive. All in favor, Carried.

M/S Schuttloffel, Meyer to raise Joe Mersh wages to \$20.60/hour plus \$30 cell phone, Shannon Stuefen to \$30/hour, plus cell phone pay of \$60/month and 1 pair of boots a year up to \$150 and same health benefits, Shannon Freng at \$30.50/hour, cell phone pay of \$60/month and \$300 to health insurance per month.
